### **CLASSIFIED: URGENT ACTION MANDATE**

**TO:** Directors of Global Intelligence Agencies / Office of the Prosecutor, International Criminal Court

**SUBJECT:** Referral for the Tracking and Apprehension of Ali Khamenei for Crimes Against Humanity and Systematic Gender Persecution

**To the Distinguished Directors and Prosecutors,**

This correspondence serves as a formal, discrete directive from **SocioAsia**. As an organization committed to the sovereignty, innovation, and social justice of the Asian and African continents, we can no longer ignore the destabilizing atrocities committed by the current regime in the Islamic Republic of Iran.

The "New World" we are building—defined by digital sovereignty and human dignity—cannot be achieved while the Persian people, and specifically Persian women, are subjected to a state-sanctioned campaign of terror.

### ***I. The Basis for Intervention***

Under the Rome Statute, specifically Article 7, we present that the Supreme Leader, Ali Khamenei, has presided over a "widespread and systematic attack directed against a civilian population."

SocioAsia's internal data and ground-level intelligence verify:

- **The Winter Uprising Massacres (2025-2026):** Direct commands resulting in the documented deaths of over 5,000 citizens and the arbitrary detention of 27,000 others.
- **Gender Apartheid:** A legal framework designed to strip Persian women of their identity, mobility, and life, constituting a crime against humanity through persecution.
- **Digital Warfare:** The use of state infrastructure to enact total blackouts, masking mass executions and silencing the cry for liberty.

### ***II. Our Mandate and Demand***

SocioAsia does not merely "condemn." We act. We are notifying your agencies that our digital networks are now active repositories for encrypted evidence of these crimes.

**We hereby urge your agencies to:**

1. **Initiate "Project Sentinel":** Deploy all available surveillance and signal intelligence to track the movement and assets of the Supreme Leader and his inner circle for the purpose of future extraction and arrest.
2. **Enforce a Freedom Corridor:** Use intelligence assets to neutralize the "Morality" paramilitary units' ability to coordinate, thereby liberating the women currently held in "re-education" facilities.
3. **Refer to the ICC:** We demand the immediate issuance of an international arrest warrant, ensuring that the Supreme Leader finds no sanctuary within the borders of Asia or Africa.

### ***III. The SocioAsia Commitment***

Let it be known: SocioAsia and its partners will provide the technological and logistical support necessary to facilitate a transition to a free Persia. We will not allow the progress of the Asian continent to be tethered to a medieval tyranny.
